## ASSESSMENT

- The examinations will be online/computer-based, 75 to 100 multiple-choice questions (MCQ) to be completed in 120 minutes.
- Each exam sitting will be conducted on a Saturday or on a preferred date on weekdays. CII booking policy applies.
